

**OWENSVILLE TOWN COUNCIL  
SPECIAL MEETING  
APRIL 16, 2010  
8:00 AM**

The Owensville Town Council met in special session on April 16, 2010. The meeting was called at approximately 8:00am. All three council members were present. Others present included: Kristy York, Clerk Treasurer; Town Employees of Randy Ross and Dean Short. Andrea from the Star Times was also present in the meeting, as well as Mrs. Rob Phares from Dayspring Church.

**EXECUTIVE SESSION MEETING PRIOR TO SPECIAL SESSION**

The Council decided to reconvene the interview process on Monday, April 19<sup>th</sup> at 8:00am. They wanted to continue the interview process with Billy Ross.

**DAYSPRING CHURCH'S RECYLING TRAILER**

Mrs. Rob Phares was present to address the Council's concerns regarding their recycling trailer that they had requested to park on the Town's square in the April 12<sup>th</sup> meeting of the Council. Dale explained to her that the Council was concerned about the leakage and mess this might create on the Town square. The fact that the leakage could attract bees and other unwanted rodents or creatures also concerned the Council. Dale suggested that they park the trailer on the square while someone tends to it on weekends or special events. Mrs. Phares agreed with this suggestion and she will take the information back to the church.

**MAY EMPLOYEE MEETING**

The Employee meeting for May will be held on Monday, May 3, 2010 at 8:00am. This was changed to due to the Town being closed on May 4, Election Day.

**ROOFING AT THE SEWER PLANT AND OLD SHOP BUILDING**

The Council asked Dean to look into getting the buildings at the sewer plant roofed with metal. The lab and old shop buildings are both in need of new roofs. In 2009, the council received quotes to have the buildings roofed with shingles. The Council tabled the quotes, as they felt the cost was a little much plus they wanted to look into the metal roofing. Dean will pursue these quotes.
